Inspection and notice procedure

Period for the exercise of public rights

- 14.—(1) Any rights of objection, inspection and questioning of the local auditor confenced by sections 26 and 27 of the Act may only be exercised within a single period of 30 working thys.
- (2) The period referred to in puragraph (1) stants with the day on which the period for the exercise of public rights is treated as having been commenced in accordance with regulation 15(3).
- (3) During the period for the exercise of public nights a relevant authority must make the documents referred to in section 26(1) of the Act available for inspection on reasonable native at all reasonable times.

Commencement of the period for the exercise of public rights

- 15.—(1) The responsible financial officer for a relevant authority must, on belong of the authority, ensure that commencement of the period for the exercise of public rights under regulation 9(1)(b) or 12(3)(a) (as the case may be), takes place on such a day that ensures that the period referred to in regulation 14(1) includes—
 - (e) the first 110 working days of time of the furnicial pear immediately following the end of the financial year to which the statement addates, where that authority is a Cotegory 1 matherity; or
 - (b) the first 10 working days of July of the branchid year immediately following the end of the financial year to which the statement relates, where that arithmity is a Category 2 authority.

The annual audit of the Parish Council includes the opportunity for electors to inspect the accounts over a given period. For the year ended 31st March 2017 this period is between 19th June and 28th July. The accounts are available for inspection during office opening times (9.30 – 12.30).
